Legislative Session

Many Texas conservatives continue to express extreme disappointment with the current legislative session. There is a lot more spending (twice the rate of growth plus inflation), butchered property tax reform, no action on constitutional carry, strongly opposed mental health legislation, letting the UN (through the Land Commission) ruin the sanctity of the Alamo cenotaph, and ignoring many GOP priorities. In particular, adding a sales tax to offset part of the property tax is dangerous if the property tax is not eliminated, as it will still go up!
